COURSE DESCRIPTION

Islamic Finance for Academicians is a 4-day intensive workshop targeted for faculty members, researchers and trainers of academic institutes, which focuses on development of skills for teaching, training and designing Islamic Finance programs' curriculum, on discussion of potential research areas in Islamic Banking and Finance, Islamic Capital Markets and the scope and challenges of Islamic Finance at the local and global levels.

The workshop's core focus areas include emerging areas in Islamic Finance, curriculum for Islamic Finance certificate programs and graduate programs, Islamic Capital Markets, Islamic law of contracts, Islamic Banking and current research areas in Islamic Finance.
